## 1. Apologies for Absence

## 2. Declarations of Interest

Cllr Cribb declared an interest in 2 planning applications, agenda item 8.

## 3. Minutes - confirmation of

## 4. Friday Friendship Group

A report from the Friday Group Committee has been circulated to members prior to the meeting. Cllr Easeman & Cllr Smith had nothing more to add. Cllr Easeman commented on how well the group is managed by the volunteers on the committee.

## 5. Helping Hands Project

Cllr Fuchter reported there were no issues arising however numbers were dropping and not as many services now attending. He suggested revisiting and assessing the situation after Christmas. Cllr Howard read an email from BC relating to the Town's Emergency Plan. Cllr Howard raised concerns of the lack of information on the BC Plan and believed other possible causes of emergencies were not adequately covered.
